Home Host (the "Host") shall protect, indemnify and hold the Grand Haven Spring Lake Ferrysburg Chamber of Commerce (the "Chamber") harmless of any claim, action, proceeding or suit instituted or threatened against the Chamber arising from the Host's acceptance of a guest artist into the Host's home and environs.

Guest Artist (the "Guest") shall protect, indemnify and hold the Chamber harmless of any claim, action, proceeding or suit instituted or threatened against the Chamber arising from the Guest's acceptance of lodging offered by the Host.

In the event that the Chamber is made a party to any action for damages related to such acceptance, brought by either the Host or the Guest, then the Host and Guest shall pay all reasonable and necessary costs and attorney's fees incurred by the Chamber in connection with that claim, action, proceeding or litigation and appeal.
