ESSENTIAL OVERALL FUNCTIONS

- Instructs swimming lessons in accordance with YMCA guidelines, having prepared lesson plans accordingly, and supports members and program participants in achieving their goals.
- Develops and maintains positive relationships with volunteers, members or program participants, and colleagues at all levels of the organization; helps participants and families connect with each other and the YMCA; and encourages parent or caregiver involvement.
- > Conveys information on aquatics programs and schedules and as appropriate refers program participants and families to other programs.
- Maintains records as required (e.g., attendance, progress reports).
- > Follows all YMCA policies, rules, regulations and procedures, including emergency and safety procedures. Completes incident and accident reports as necessary.
- Organizes, maintains and puts away needed pool and deck equipment. Reports damaged equipment.
- > Trains and supervises class aides as assigned.
- > Ensures State of Michigan's Department of Health requirements are met.
- > Follows proper emergency procedures.
- > Performs any other functions necessary for the smooth and efficient operation of the organization.

QUALIFICATIONS

- At least 16 year of age.
- > YMCA Swim Instructor certification, or equivalent preferred.
- Lifeguard Certification, or equivalent preferred.
- Certifications to be completed within 30 days of employment:
 - o Basic Life Support, First Aid and Bloodborne Pathogens certification
 - Child Abuse Prevention training.
- Six months to one year of recreation, lifeguard, swim instructor, or water park experience; or equivalent combination of education, training, and experience required.
- Must be able to demonstrate swim instructor skills in accordance with YMCA standards.
- Ability to interact with people of all backgrounds, ages, and lifestyles.
