### Correction: SBA Working Capital Loans Available in Michigan for Secretary of Agriculture Disaster Declaration for 2021 Drought

**ATLANTA** - The [U.S. Small Business Administration](#) announced today that Economic Injury Disaster Loans (EIDLs) are available in **Michigan** to small businesses, small agricultural cooperatives, small businesses engaged in aquaculture, and most private nonprofit organizations due to drought that began on May 5, 2021.

The declaration covers the primary counties of Allegan, Antrim, Baraga, Gogebic, Grand Traverse, Houghton, Iron, Kalkaska, Leelanau, Ontonagon and Otsego in **Michigan**; and the contiguous counties of Barry, Benzie, Charlevoix, Cheboygan, Crawford, Dickinson, Kalamazoo, Kent, Keweenaw, Manistee, Marquette, Missaukee, Montmorency, Oscoda, Ottawa, Roscommon, Van Buren and Wexford in **Michigan**; and Florence, Forest, Iron and Vilas in **Wisconsin**.

“When the Secretary of Agriculture issues a disaster declaration to help farmers recover from damages and losses to crops, the Small Business Administration issues a declaration to eligible entities, affected by the same disaster,” said Kem Fleming, director of SBA’s Field Operations Center East.

Under this declaration, the SBA’s Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster. Apart from aquaculture enterprises, SBA cannot provide disaster loans to agricultural producers, farmers, and ranchers. Nurseries are eligible to apply for economic injury disaster loans for losses caused by drought conditions.

The loan amount can be up to \$2 million with interest rates of **2.88** percent for small businesses and **2** percent for private nonprofit organizations, with terms up to 30 years. These working capital loans may be used to pay fixed debts, payroll, accounts payable, and other bills that could have been paid had the disaster not occurred. The loans are not intended to replace lost sales or profits.

Applicants may apply online using the Electronic Loan Application (ELA) via the SBA’s secure website at [DisasterLoanAssistance.sba.gov/ela/s/](https://DisasterLoanAssistance.sba.gov/ela/s/) and should apply under SBA declaration # 17317, not for the COVID-19 incident.
