Position Title: Community Living Program-Direct Care Worker

### **General Description:**

Performance of routine household, personal care, and respite to support an adequate and safe living environment for older adults, age 60+, with functional limitations.

### **Essential Duties and Responsibilities:**

- Assistance with activities of daily living
- Respite for the Caregiver
- Light housekeeping tasks including dusting, vacuuming, mopping floors, cleaning bathrooms and kitchens, making beds, laundry services and maintaining a safe and healthy living environment.
- Shopping for necessities including groceries
- Maintain appropriate boundaries with clients and their family
- Meal preparation
- Observe, report and record any change in client's condition and home environment
- Maintain consistent client schedule, and immediately contact clients and supervisor regarding absences.

#### **Qualifications:**

- Previous experience for working with older adults
- Ability to work with older adults with functional limitations and provide personal care support services.
- Thorough and efficient, able to work independently
- Ability to perform housekeeping, laundry and cleaning tasks
- Ability to maintain accurate records
- Must be friendly and demonstrate a caring attitude at all times
- Reliable transportation with ability to serve north Ottawa clients. Valid MI drivers license and car insurance.
- Able to lift and/or move at least 10 pounds.

- Attend periodic in-services, professional conferences, meetings and seminars; and represent agency on committees, as assigned
- Works as part of a team
- Maintain confidentiality
- Maintain monthly reporting and documenting requirements
- Perform all other duties assigned
