WORKPLACE WELLNESS AGREEMENT: THE CHAMBER OF COMMERCE

Purpose: The Tri-Cities Family YMCA (YMCA) has been strengthening the community since 1963. This proposal represents the Y's efforts to collaborate with the Grand Haven, Spring Lake, Ferrysburg Chamber of Commerce (the Chamber) to provide wellness opportunities to its members.

SECTION 2- CHAMBER OF COMMERCE MEMBERSHIP BENEFITS

As part of this Corporate Wellness Agreement, the YMCA will offer Chamber member businesses a special membership offer and workplace wellness benefits. To receive this discount and benefits, a representative from the business must set up a Workplace Wellness Agreement directly with the YMCA.

OFFER

- **20% discount** on monthly membership rates for the first six months. After six months the discount will automatically be removed from unit and a standard discount may be applied if the business indicates they would like to continue in the Workplace Wellness program.
- **Open Enrollment**
 - April 14, 2025 - December 31, 2025, \$0 joining fee for any new YMCA membership
- Chamber member employees must be an active member on the membership unit to receive the discount (i.e., this does not apply to Youth Memberships).

SECTION 3- CHAMBER MEMBER RESPONSIBILITIES

- Chamber Members must indicate their affiliation with the Chamber of Commerce to receive member benefits.
- A representative from the Chamber member's business must contact the YMCA to set up discount for their business's employees.
- Membership fees are the total responsibility of the Chamber member.
- Chamber members wishing to cancel their memberships are required to provide 30-day written notice from their draft date to the YMCA.

SECTION 4 – PROPOSED AGREEMENT

The Tri-Cities Family YMCA is a cause-driven organization that ensures members of our community have the opportunities they need to stay healthy. The Y will collaborate with the Chamber to achieve the goal of positively impacting the health and well-being of its members and their employees.

The Y agrees to provide the following:

- The Y will provide the above membership incentives to Chamber members with the goal of obtaining new memberships and improving the health and wellness of its members and their employees.
- The Y will provide informational materials about its programs and services and be available for support to all Chamber members.
- If the YMCA wishes to terminate or alter the terms of this proposal, it will provide 30-day notice to the Chamber.
- The YMCA will review, with the Chamber, membership trends generated by this proposal in December 2025 and determine continuation of or amendments to the terms of this proposal.

The Chamber of Commerce agrees to the following:

- The Chamber will communicate with its members regarding the membership and program benefits offered by the Y.
- If the Chamber wishes to terminate or alter the terms of this proposal, it will provide 30-day notice to the YMCA.
- The Chamber will review with the YMCA membership trends for its members in December 2025 and determine continuation of, or amendments to, the terms of this proposal.
- If both parties agree to continue the agreement, the Chamber will review a list of members in their discount group to confirm those members still qualify. This will take place annually for the duration of the agreement.
